NEW YORK STATE CHAPTER, AMERICAN COLLEGE OF CARDIOLOGY 2017 YOUNG INVESTIGATORS'/CASE PRESENTERS' AWARD COMPETITION

- Any FIT who is currently enrolled in a cardiovascular fellowship training or an advanced cardiology subspecialty training program, resident who is enrolled in a cardiovascular residency program or medical student who has participated in cardiovascular research in New York State may compete in the New York State Chapter, ACC Young Investigators/Case Presenter Competition.
- The scientific abstracts receiving the highest scores will be displayed as posters during the 89th Annual Scientific Session of The New York Cardiological Society, with awards presented to the Top 3. Each of the three awardees will receive a \$200 cash award, a Winner Certificate, and a grant to cover travel expenses and one night's lodging if required. The meeting is scheduled for Thursday, Dec. 7, 2017, at the Prince George Ballroom in New York City.
- The two (2) best clinical cases will be selected for oral presentation at the same meeting. The selected winners will briefly present the clinical case, followed by a detailed discussion by their mentors.

The name and signature of the cardiology mentor is required for the case submission to be considered. IMPORTANT: The cardiology mentor sponsoring the clinical case is expected to present and discuss the case during our meeting in the event that the case is selected. No case will be presented without a formal presentation by the cardiology mentor.

- Scientific abstracts previously presented at national scientific sessions may be submitted.
- There is no limit to the number of abstracts/cases that can be submitted by an individual.
- The deadline for abstract/case submission is Friday, Oct. 20, 2017. Submissions will be evaluated by the New York State Chapter's Awards Committee. Winners will be notified within six weeks of the submission deadline date.

ABSTRACT FORMAT GUIDELINES

- 1. Abstracts are limited to 2,250 characters. Each table or graph counts as 425 characters. Spaces and headings do not count as characters.
- 2. The title should be brief and should clearly indicate the nature of the investigation. Type title in all capital letters, spell out all words, omit abbreviations used in text, and do not underline.
- 3. Type the name and location of the institution and the complete/full names and principal degrees of all authors, including FACC/MACC where applicable.
- 4. Content should be structured into 4 sections:
 - Background Methods Results Conclusions

ABSTRACT SUBMISSION GUIDELINES

- 1. Completed abstracts must submitted online at <u>www.ny-acc.org/getting-involved/yic</u> by clicking on "Upload Your Abstract." This will take you to a Dropbox page. Please upload your document there.
- 2. Completed abstracts must be submitted by 5:00 p.m. EST on Friday, Oct. 20, 2017.
- 3. Incomplete submissions will not be processed. Verify your information carefully before submitting. Abstracts cannot be edited.
- 4. Submission of an abstract constitutes a commitment to be present, if accepted. Failure to be present will jeopardize future acceptance of abstracts.

CLINICAL CASE FORMAT GUIDELINES

- The case description should be limited to one (1) typed page. The title should be brief and clearly indicate the nature of the investigation. Type title in all capital letters, spell out all words, omit abbreviations used in text, and do not underline.
- 2. Type the name and location of the institution and the complete names and principal degrees/certifications of all authors, including FACC/MACC, where applicable.
- 3. Describe the case, the diagnostic modalities, and the therapeutic procedures performed, as applicable.
- 4. Discuss the unique aspects of the case that would merit presentation at our annual scientific session.
- 5. IMPORTANT: The cardiology mentor sponsoring the clinical case is expected to present and discuss the case during our meeting in the event that the case is selected. No case will be presented without a formal presentation by the cardiology mentor.

- 2. Clinical cases must be submitted by 5:00 p.m. EST on Friday, Oct. 20, 2017.
- 3. Incomplete submissions will not be processed. Verify your information carefully before submitting. Clinical cases cannot be edited.
- 4. Submission of a clinical case constitutes a commitment for both the submitting individual and the cardiology mentor to be present, if accepted.
